The **five items** are: Protein; 1 Fruit choice except for high school they may have 2 fruits or 1 fruit and 1 juice; 1 of each Vegetable offered; a Bread/Grain choice; and Milk choice.

Some of our items can count as 2 items, (Protein and Bread/Grain): Hamburger, Pizza, Sandwich, Spaghetti and meatballs.

If a student only wants a few items they will be charged individual prices. See below for prices.
